**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION GRANTING AN UNOPPOSED MOTION TO TERMINATE THE
INVESTIGATION AS TO RESPONDENTS ZTE CORPORATION AND ZTE (USA) INC.
BASED UPON SETTLEMENT**

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 22) granting an unopposed motion to terminate the investigation as to respondents ZTE Corporation of Shenzhen, China and ZTE (USA) Inc. of Iselin, New Jersey and Richardson, Texas (collectively, "ZTE") based upon settlement.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on June 25, 2013, based on a complaint filed by Graphics Properties Holdings, Inc. of New Rochelle, New York ("Graphics Properties"). 78 *Fed. Reg.* 38073 (June 25, 2013). The complaint alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain consumer electronics with display and processing capabilities by

reason of infringement of certain claims of United States Patent Nos. 6,650,327; 8,144,158; and 5,717,881. The notice of investigation named several entities as respondents, including ZTE.

On July 17, 2013, Graphics Properties and ZTE filed an unopposed motion to terminate the investigation as to ZTE based upon settlement. On July 26, 2013, the Commission investigative attorney filed a response in support of the motion. No other responses to the motion were filed.

On August 22, 2013, the ALJ issued the subject ID, granting the motion. The ALJ found that the settlement agreement complies with the requirements of Commission Rule 210.21(b) (19 C.F.R. § 210.21(b)) and that terminating ZTE from the investigation would not be contrary to the public interest. None of the parties petitioned for review of the ID.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
