INITIAL DETERMINATION EXTENDING THE TARGET DATE FOR THE  
COMPLETION OF THE INVESTIGATION**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 21) extending the target date for the completion of the investigation by 10 days to January 9, 2017.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on September 1, 2015, based on a complaint filed by SawStop, LLC, and SD3, LLC ("Complainants"). 80 Fed. Reg. 52791-92 (Sept. 1, 2015). The amended complaint alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain table saws incorporating active injury mitigation technology and components thereof by reason of infringement of certain claims of United States Patent Nos. 7,225,712; 7,600,455; 7,610,836; 7,895,927;

8,011,279; and 8,191,450. The notice of investigation named as respondents Robert Bosch Tool Corp. of Mount Prospect, Illinois, and Robert Bosch GmbH of Baden-Wuerttemberg, Germany. *Id.* at 52792. The Office of Unfair Import Investigations (OUII) is not a party to the investigation. *Id.*

On August 22, 2016, the ALJ issued the subject ID, extending the target date for the investigation by ten days. The Commission notes that the ID contains a typographical error, and clarifies that target date is extended to January 9, 2017. No petitions for review of the subject ID were filed.

The Commission has determined not to review the subject ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 C.F.R. Part 210).
