### 6. AUTHORITY AND RATIONALE

This acquisition is being conducted under the authority of the Multiple-Award Schedule Program. The proposed action may be awarded on a limited sources basis under the following authority: *Check box below and provide supporting rationale*.

- C FAR Subpart 8.405-6(a)(1)(i)(A) An urgent and compelling need exists, and following the procedures would result in unacceptable delays;

Officer of Chief Information Officer requires Intel and Q logic branded network adapters because our visualization and back-up servers have finite space and considerable network requirements only these parts and specific models provide. Other manufacturers do not reliably provide parts that fit in our servers or ensure the same network speed and reliably the named brands do.

### 7. DETERMINATION OF BEST VALUE

In accordance with FAR Subpart 8.404(d), services offered on Federal Supply Schedules are priced either at hourly rates, or at a fixed price for performance of a specific task.
