Sodium Nitrite from Russia

DETERMINATION

On the basis of the record¹ developed in the subject investigation, the United States International Trade Commission ("Commission") determines, pursuant to the Tariff Act of 1930 ("the Act"), that an industry in the United States is materially injured by reason of imports of sodium nitrite from Russia, provided for in subheading 2834.10.10 of the Harmonized Tariff Schedule of the United States, that have been found by the U.S. Department of Commerce ("Commerce") to be sold in the United States at less than fair value ("LTFV").²

BACKGROUND

The Commission instituted this investigation effective January 13, 2022, following receipt of antidumping and countervailing duty petitions filed with the Commission and Commerce by Chemtrade Chemicals US LLC, Parsippany, New Jersey. The Commission established a general schedule for the conduct of the final phase of its investigations of sodium nitrite from India and Russia following publication of a preliminary determination by Commerce that imports of sodium nitrite were subsidized by the government of Russia. Notice of the scheduling of the final phase of the Commission's investigations and of a public hearing to be held in connection therewith was given by posting copies of the notice in the Office of the Secretary, U.S. International Trade Commission, Washington, DC, and by publishing the notice in the *Federal Register* of April 20, 2022 (87 FR 23567). In light of the restrictions on access to the Commission building due to the COVID–19 pandemic, the Commission conducted its hearing through written testimony and video conference on June 21, 2022. All persons who requested the opportunity were permitted to participate.

The investigation schedules became staggered when Commerce did not align its countervailing duty investigation on Russia with either of the corresponding antidumping duty

investigations; did not postpone the final determination of its antidumping duty investigation on Russia; and aligned its countervailing duty investigation on sodium nitrite from India with its postponed antidumping duty investigation regarding India. On August 15, 2022, the Commission issued a final affirmative determination in its countervailing duty investigation of sodium nitrite from Russia (87 FR 51141, August 19, 2022). Following publication of a final determination by Commerce that imports of sodium nitrite from Russia were being sold at LTFV within the meaning of section 735(a) of the Act (19 U.S.C. 1673d(a)), notice of the supplemental scheduling of the final phase of the Commission's antidumping duty investigation on Russia was given by posting copies of the notice in the Office of the Secretary, U.S. International Trade Commission, Washington, DC, and by publishing the notice in the *Federal Register* of September 23, 2022 (87 FR 58136).

Views of the Commission

Based on the record in the final phase of this investigation, we determine that an industry in the United States is materially injured by reason of imports of sodium nitrite from Russia found by the U.S. Department of Commerce ("Commerce") to be sold in the United States at less than fair value.

I. Background

The petitions in the antidumping and countervailing duty investigations of imports of sodium nitrite from India and Russia were filed on January 13, 2022 by Chemtrade Chemicals US LLC ("Chemtrade"), a domestic producer of sodium nitrite.¹ The investigation schedules became staggered into three stages when the U.S. Department of Commerce ("Commerce") did not align its countervailing duty investigation on Russia with either of the antidumping duty investigations;² did not postpone the final determination of its antidumping duty investigation on Russia;³ and aligned its countervailing duty investigation of sodium nitrite from India with its postponed antidumping duty investigation regarding India.⁴ This necessitated an earlier Commission determination in the final countervailing duty investigation of sodium nitrite from

Russia ("leading investigation"). The Commission published its final affirmative determination regarding subsidized imports in the leading investigation in August 2022.⁵

Subsequently, Commerce published its final affirmative determination in the antidumping duty investigation concerning Russia on September 12, 2022.⁶ As a result, the Commission must now make its determination in the antidumping duty investigation on sodium nitrite from Russia ("trailing Russia investigation") and will make its determinations in the other trailing investigations at a later date following Commerce's related final determinations.⁷ Pursuant to the statutory provision on staggered investigations, the record for the current trailing investigation closed on July 19, 2022, at the same time as the record for the leading investigation, except that the final Commerce antidumping duty determination on subject imports from Russia and any party's supplemental comments concerning that determination have been added to the record.^{8 9}

II. Negligible Imports

Pursuant to Section 771(24) of the Tariff Act, imports from a country subject to an investigation corresponding to a domestic like product that account for less than 3 percent of all such merchandise imported into the United States during the most recent 12 months for

which data are available preceding the filing of the petition shall generally be deemed negligible.¹⁰

During the 12-month period prior to the filing of the petitions (January 2021 through December 2021), subject imports of sodium nitrite from Russia in the antidumping duty investigation accounted for 7.1 percent of total imports of sodium nitrite.^{11 12} Accordingly, we find that the subject imports from Russia are not negligible for purposes of the antidumping duty investigation.

III. Material Injury by Reason of Subject Imports

Section 771(7)(G)(iii) of the Tariff Act of 1930, as amended ("the Act"), provides that the

Commission must make its material injury determination in the trailing Russia investigation on

the basis of the same record as that in the leading investigation, except to the extent discussed

above.¹³ Therefore, in this investigation, we adopt the findings and analyses from our

determination and views regarding subject imports from the leading investigation with respect

to the issues of domestic like product, domestic industry, cumulation, conditions of

competition, and material injury by reason of cumulated subject imports.^{14 15}

Accordingly, we determine that an industry in the United States is materially injured by reason of subject imports of sodium nitrite from Russia found by Commerce to be sold in the United States at less than fair value.

calculated dumping margins of 207.17 percent for Uralchem, JSC and all others. *Sodium Nitrite From the Russian Federation: Final Affirmative Determination of Sales at Less Than Fair Value*, 87 Fed. Reg. 55781 (Sep. 12, 2022); Supplemental CR/PR at Table I-2. The margins are unchanged from Commerce's preliminary determination. *See Sodium Nitrite Leading Determination*, USITC Pub 5342 at I-6. The Commission notes that no individual producers/exporters in this trailing investigation were excluded from Commerce's final affirmative determination.

As part of our analysis, we have taken into account Commerce's final determination that subject imports from Russia are sold in the United States at less than fair value. In addition to this consideration, other factors that support our analysis from the leading determination in *Sodium Nitrite Leading Determination* remain unchanged and do not require modification of that analysis; in turn, our analysis of the significant price effects of cumulated subject imports found in the leading determination is especially probative to our assessment of the impact of subject imports from Russia on the domestic industry. *See Sodium Nitrite Leading Determination*, USITC Pub. 5342 at 31-34.

Part I: Introduction

Background

These investigations result from petitions filed with the U.S. Department of Commerce ("Commerce") and the U.S. International Trade Commission ("USITC" or "Commission") by Chemtrade Chemicals US LLC, Parsippany, New Jersey, on January 13, 2022, alleging that an industry in the United States is materially injured and threatened with material injury by reason of subsidized and less-than-fair-value ("LTFV") imports of sodium nitrite¹ from India and Russia. Table I-1 presents information relating to the background of this investigation.^{2 3}

The information contained in this report is intended to be used in conjunction with data presented in the Commission's report on *Sodium Nitrite from Russia, Investigation No. 701-TA-680 (Final)*, USITC Publication 5342, August 2022, and its corresponding confidential report contained in memorandum No. INV-UU-074, *Sodium Nitrite from India and Russia: Investigation Nos. 701-TA-679-680 and 731-TA-1585-1586 (Final)*, revised by memorandum No. INV-UU-075 (July 12, 2022).^{4 5} No new information except for Commerce's final LTFV determinations concerning sodium nitrite from Russia, and party comments thereon is included in the record for this proceeding.⁶

Nature and extent of sales at LTFV

On September 12, 2022, Commerce published a notice in the Federal Register of its final determination of sales at LTFV with respect to imports from Russia⁷. Table I-2 presents Commerce's dumping margins with respect to imports of product from Russia.

Negligibility

The statute requires that an investigation be terminated without an injury determination if imports of the subject merchandise are found to be negligible.⁸ Negligible imports are generally defined in the Act, as amended, as imports from a country of merchandise corresponding to a domestic like product where such imports account for less than 3 percent of the volume of all such merchandise imported into the United States in the most recent 12-month period for which data are available that precedes the filing of the petition or the initiation of the investigation. However, if there are imports of such merchandise from a number of countries subject to investigations initiated on the same day that individually account for less than 3 percent of the total volume of the subject merchandise, and if the imports from those countries collectively account for more than 7 percent of the volume of all such merchandise imports from such countries are deemed not to be negligible.⁹ Imports from Russia accounted for 7.1 percent of total imports of sodium nitrite by quantity during 2021.
