DETERMINATION AMENDING TARGET DATE AND PROCEDURAL SCHEDULE**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 29) of the presiding administrative law judge (“ALJ”), moving the target date for completion of the investigation to Friday, February 23, 2018.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on August 9, 2016, based on a complaint filed on behalf of The Chamberlain Group, Inc. (“CGI”) of Elmhurst, Illinois. 81 FR 52713 (Aug. 9, 2016). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, by reason of infringement of certain claims of U.S. Patent Nos. 7,161,319; 7,196,611; and 7,339,336. The complaint further alleges that a domestic industry exists. The Commission’s notice of investigation named as respondents Techtronic Industries Co. Ltd. of Tusen Wan, Hong Kong; Techtronic Industries North America, Inc. of Hunt Valley, Maryland; One World Technologies Inc. of Anderson, South Carolina; OWT Industries Inc. of Pickens, South Carolina; Ryobi Technologies, Inc. (“Ryobi”) of Anderson, South Carolina; and Et Technology (Wuxi) Co., Ltd., of Zhejiang, China. The Office of Unfair Import Investigations is not participating in the investigation. Respondent Ryobi was terminated

from the investigation on November 7, 2016. *See* Order No. 6 (Oct. 17, 2016); *not rev'd by Comm'n Notice* (Nov. 7, 2016).

On May 3, 2017, the Commission vacated an initial determination (Order No. 23) granting summary determination of non-infringement of U.S. Patent No. 7,161,319 in this investigation, and remanded to the ALJ for further proceedings. Thereafter, on May 8, 2017, the ALJ issued the subject ID (Order No. 29) moving the target date for completion of the investigation to Friday, February 23, 2018. The ID indicates that any final initial determination would be due by Monday, October 23, 2017. No party petitioned for review.

The Commission has determined not to review the subject ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, and in Part 210 of the Commission's Rules of Practice and Procedure, 19 C.F.R. Part 210.
