SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review a February 5, 2019 initial determination ("ID") (Order No. 46) extending until October 4, 2019, the target date in this investigation in view of the shutdown of the Federal Government.

SUPPLEMENTARY INFORMATION: On March 16, 2018, the Commission instituted this investigation based on a supplemented complaint filed on behalf of Rovi Corporation of San Jose, CA; Rovi Guides, Inc. of San Jose, CA; Veveo, Inc. of Andover, MA; and Rovi Technologies Corporation of San Jose, CA. The supplemented complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain digital video receivers and related hardware and software components by reason of infringement of one or more claims of U.S. Patent No. 7,779,011 ("the '011 patent"); U.S. Patent No. 7,937,394 ("the '394 patent"); U.S. Patent No. 7,827,585 ("the '585 patent");

U.S. Patent No. 9,294,799 ("the '799 patent"); U.S. Patent No. 9,396,741 ("the '741 patent"); U.S. Patent No. 9,578,363 ("the '363 patent"); U.S. Patent No. 9,621,956 ("the '956 patent"); and U.S. Patent No. 9,668,014 ("the '014 patent"). 83 FR 11792 (Mar. 16, 2018). The Commission's notice of investigation named as respondents Comcast Corporation of Philadelphia, PA; Comcast Cable Communications, LLC of Philadelphia, PA; Comcast Cable Communications Management, LLC of Philadelphia, PA; Comcast Business Communications, LLC of Philadelphia, PA; and Comcast Shared Services, LLC of Chicago, IL. *Id.* The Office of Unfair Import Investigations was also named as a party in this investigation. *Id.*

This investigation has previously terminated as to complainant Rovi Technologies Corporation; as to the '956, '394, '014, '799, and '353 patents in their entirety; and as to certain claims of the '011, '585, '741, and '363 patents. Order No. 12, *unreviewed*, Notice (July 24, 2018); Order No. 34, *unreviewed*, Notice (Sept. 19, 2018); Order 39, *unreviewed*, Notice (Oct. 25, 2018).

On February 5, 2019, the presiding administrative law judge issued Order No. 46, the subject ID, which extends until October 4, 2019, the target date in this investigation due to the shutdown of the Federal Government. The ID indicates that the final ID on violation will issue by June 4, 2019. No party filed a petition seeking review of the ID. The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in part 210 of the Commission's Rules of Practice and Procedure (19 CFR part 210).
