**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN  
INITIAL DETERMINATION GRANTING COMPLAINANT'S MOTION TO  
TERMINATE THE INVESTIGATION IN PART WITH RESPECT TO  
U.S. PATENT NO. 10,141,335 AND CERTAIN ASSERTED CLAIMS OF U.S.  
PATENT NOS. 10,141,334 and 10,186,523**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 36) of the presiding Administrative Law Judge ("ALJ") granting complainant's motion to terminate the investigation in part with respect to U.S. Patent No. 10,141,335 ("the '335 patent") and certain asserted claims of U.S. Patent Nos. 10,141,334 ("the '334 patent") and 10,186,523 ("the '523 patent").

**SUPPLEMENTARY INFORMATION:** On March 15, 2019, the Commission instituted this investigation under section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, on March 15, 2019, based on a complaint filed by Tela Innovations, Inc. of Los Gatos, California ("Tela"). 84 *Fed. Reg.* 9558-59 (Mar. 15, 2019). The complaint, as supplemented, alleges a

violation of section 337 by reason of infringement of certain claims of U.S. Patent Nos. 7,943,966 (“the ’966 patent”); 7,948,012 (“the ’012 patent”); the ’334 patent; the ’335 patent; and the ’523 patent. The notice of investigation names as respondents Acer, Inc. of New Taipei City, Taiwan; Acer America Corporation of San Jose, California; AsusTek Computer Inc. of Taipei, Taiwan; Asus Computer International of Fremont, California; Intel Corporation of Santa Clara, California; Lenovo Group Ltd. of Beijing, China; Lenovo (United States) Inc. of Morrisville, North Carolina; Micro-Star International Co., Ltd. of New Taipei City, Taiwan; and MSI Computer Corp. of City of Industry, California (collectively, “Respondents”). *Id.* at 9559. The Office of Unfair Import Investigations (“OUII”) is also named as a party in this investigation. *Id.* Subsequently, the investigation was terminated in part as to the ’966 and ’012 patents. Order No. 33 (October 2, 2019), *non-reviewed* by Notice (October 22, 2019).

On October 18, 2019, complainant Tela moved to terminate by reason of withdrawal under 19 CFR 210.21(a): (1) all asserted claims of the ’335 patent; (2) claims 6, 11, and 20 of the ’334 patent; and (3) claim 12 of the ’523 patent. Mot. at 1. The motion represents, *inter alia*, that “Respondents do not oppose this Motion.” *Id.* at 2. On October 23, 2019, OUII filed a statement in support of the motion.

On October 23, 2019, the ALJ issued the subject ID granting Tela’s motion. The ID found that there are no extraordinary circumstances that would prevent the requested partial termination of this investigation. ID at 2. The ID also found that Tela has complied with the requirements of 19 CFR 210.21(a). *Id.* No party petitioned for review of the ID, and the Commission has determined not to review it.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, and in Part 210 of the Commission’s Rules of Practice and Procedure, 19 CFR part 210.
