**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW INITIAL  
DETERMINATIONS TERMINATING THE INVESTIGATION AS TO FOUR  
RESPONDENTS BASED ON CONSENT ORDER STIPULATIONS; ISSUANCE OF  
FOUR CONSENT ORDERS**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined not to review four initial determinations (Order Nos. 37-40) granting motions to terminate Soundlink Co., Ltd., Campfire Audio, LLC, Magic Dynamics, LLC d/b/a MagicEar, and Dongguan Xinyao Electronics Industrial Co., Ltd. in the above captioned investigation based on consent order stipulations. The Commission has entered four consent orders.

**SUPPLEMENTARY INFORMATION:** On November 29, 2019, the Commission instituted this investigation based on a complaint filed by Knowles Corporation and Knowles Electronics, LLC of Itasca, Illinois, and Knowles Electronics (Suzhou) Co., Ltd. of Suzhou, China (collectively, “Complainants”). 84 FR 65840 (Nov. 29, 2019). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, due to the importation or sale in the United States of certain balanced armature devices, products containing same, and components thereof by reason of misappropriation of trade secrets, the threat or effect of which is to destroy or substantially injure a domestic industry. *Id.* The notice of investigation names twelve (12) respondents, including Liang Li a/k/a Ryan Li of Suzhou, China; Shenzhen Bellsing Acoustic Technology Co., Ltd. of Shenzhen, China; Suzhou Bellsing

Acoustic Technology Co., Ltd. of Suzhou, China; Bellsing Corporation of Lisle, Illinois; Dongguan Bellsing Precision Device Co., Ltd. of Dongguan, China; Dongguan Xinyao Electronics Industrial Co., Ltd. of Dongguan, China (“Xinyao”); Soundlink Co., Ltd. of Suzhou, China (“Soundlink”); Magnatone Hearing Aid Corporation d/b/a Persona Medical and InEarz Audio of Casselberry, Florida; Jerry Harvey Audio LLC of Orlando, Florida; Magic Dynamics, LLC d/b/a MagicEar of Clearwater, Florida (“MagicEar”); Campfire Audio, LLC of Portland, Oregon (“Campfire”); and Clear Tune Monitors, Inc. of Orlando, Florida. *Id.* The Office of Unfair Import Investigations (“OUII”) is also a party in this investigation. *Id.*

On October 15, 2020, Complainants and Soundlink filed a joint motion to terminate Soundlink based on a consent order stipulation and a proposed consent order. OUII filed a response in support of the motion. On October 26, 2020, the ALJ issued Order No. 37 granting the motion. The ID finds that the motion, consent order stipulation, and proposed consent order, satisfy the requirements of Commission Rules 210.21(c)(3) and (c)(4). The ID also finds that termination of the investigation as to Soundlink would not be contrary to the public interest.

On October 16, 2020, Complainants and MagicEar filed a joint motion to terminate MagicEar based on a consent order stipulation and a proposed consent order. OUII filed a response in support of the motion. On October 26, 2020, the ALJ issued Order No. 38 granting the motion. The ID finds that the motion, consent order stipulation, and proposed consent order, satisfy the requirements of Commission Rules 210.21(c)(3) and (c)(4). The ID also finds that termination of the investigation as to MagicEar would not be contrary to the public interest.

On October 15, 2020, Complainants and Xinyao filed a joint motion to terminate Xinyao based on a consent order stipulation and a proposed consent order. OUII filed a response in support of the motion. On October 26, 2020, the ALJ issued Order No. 39 granting the motion. The ID finds that the motion, consent order stipulation, and proposed consent order, satisfy the requirements of Commission Rules 210.21(c)(3) and (c)(4). The ID also finds that termination of the investigation as to Xinyao would not be contrary to the public interest.

On October 16, 2020, Complainants and Campfire filed a joint motion to terminate Campfire based on a consent order stipulation and a proposed consent order. OUII filed a response in support of the motion. On October 26, 2020, the ALJ issued Order No. 40 granting the motion. The ID finds that the motion, consent order stipulation, and proposed consent order, satisfy the requirements of Commission Rules 210.21(c)(3) and (c)(4). The ID also finds that termination of the investigation as to Campfire would not be contrary to the public interest.

No party petitioned for review of the IDs.

The Commission has determined not to review Order Nos. 37-40. Soundlink, MagicEar, Xinyao, and Campfire are hereby terminated from the investigation. The Commission has entered four consent orders.

The Commission vote for this determination took place on November 23, 2020.

The authority for the Commission's determination is contained in Section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
