SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 19) of the presiding administrative law judge ("ALJ"), granting complainants' motion to terminate the investigation as to respondent Printed Motor Works Ltd. ("Printed Motor Works") based upon withdrawal of allegations in the complaint.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on November 6, 2020, based on a complaint filed on behalf of AutoStore Technology AS of Norway; AutoStore AS of Norway; and AutoStore System Inc. of Derry, New Hampshire. 85 FR 71096 (Nov. 6, 2020). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain automated storage and retrieval systems, robots, and components thereof by reason of infringement of certain claims of U.S. Patent Nos.: 10,093,525; 10,294,025; 10,474,140; 10,494,239; and 10,696,478. *Id.* The complaint further alleges that a domestic industry exists. *Id.* The

Commission's notice of investigation named eight respondents including Printed Motor Works of the United Kingdom. *Id.* at 71097.

On May 28, 2021, Complainants filed a motion to terminate the investigation as to respondent Printed Motor Works based on withdrawal of allegations in the complaint pursuant to Commission Rule 210.21(a), 19 CFR 210.21(a). See Order No. 19 at 1 (June 2, 2021). No party opposed the motion. *Id.* On June 2, 2021, the ALJ issued the subject ID granting the motion. *Id.* at 2. The ID finds that the motion complies with the Commission's Rules, and that no extraordinary circumstances warrant denying the motion. *Id.* No petitions for review were filed.

The Commission has determined not to review the subject ID. Respondent Printed Motor Works is terminated from the investigation.

The Commission vote for this determination took place on June 22, 2021.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, and in Part 210 of the Commission's Rules of Practice and Procedure, 19 CFR Part 210.
