**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW
AN INITIAL DETERMINATION SETTING AN 17-MONTH TARGET DATE**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined not to review an initial determination (“ID”) (Order No. 6) issued by the presiding administrative law judge (“ALJ”) setting a 17-month target date of November 7, 2023, for completion of the above-captioned investigation.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on June 6, 2022, based on a complaint, as supplemented, filed by Advanced Micro Devices, Inc. of Santa Clara and California ATI Technologies ULC of Ontario, Canada. 87 FR 34718-719 (June 7, 2022). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, in the importation into the United States, sale for importation, or sale in the United States after importation of certain graphics systems, components thereof, and digital televisions containing the same by reason of infringement of certain claims of U.S. Patent Nos. 7,742,053; 8,760,454; 8,468,547; 8,854,381; and 11,184,628. *Id.* The complaint further alleges that a domestic industry exists. *Id.*

The Commission’s notice of investigation named the following respondents: TCL Industries Holdings Co. of Guangdong, China; TCL Industries Holdings (H.K.) Ltd., Hong Kong, China; TCL Electronics Holdings Ltd. f/k/a TCL Multimedia Technology Holdings, Ltd. of Hong Kong, China; TCL Technology Group Corporation of Guangdong, China; TTE Corporation of Hong Kong, China; TCL Holdings (BVI) Ltd. of Hong Kong, China; TCL King Electrical Appliances (Huizhou) Co. Ltd. of Guangdong, China; Shenzhen TCL New

Technologies Co. Ltd. of Guangdong, China; TCL MOKA International Ltd. of Hong Kong, China; TCL Smart Device (Vietnam) Co., Ltd. of Binh Duong Province, Vietnam; Manufacturas Avanzadas SA de CV of Chihuahua, Mexico; TCL Electronics Mexico of Benito Juarez, Mexico; TCL Overseas Marketing Ltd. of Hong Kong, China; and RealTek Semiconductor Corporation of Hsinchu, Taiwan. *Id.* at 34719. The Office of Unfair Import Investigations will not participate as a party to this investigation. *Id.*

On June 28, 2022, the presiding ALJ issued the subject ID setting a 17-month target date of November 7, 2023. Order No. 6 (June 28, 2022).


No party filed a petition for review of the subject ID.

The Commission has determined not to review the subject ID. Accordingly, the target date for completion of this investigation is November 7, 2023.
