NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION GRANTING A MOTION FOR TERMINATION AS TO RESPONDENT VIZIO, INC.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 33) granting an unopposed motion for termination as to respondent VIZIO, Inc. ("VIZIO").

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on November 29, 2022, based on a complaint filed on behalf of DivX, LLC ("DivX") of San Diego, CA. 87 FR 73328 (Nov. 29, 2022). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain video processing devices and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 11,050,808; 8,832,297; 7,295,673; 10,225,588; and 11,102,553. *Id.* The complaint further alleges that a domestic industry exists. *Id.* at 62568. The Commission's notice of investigation named Amazon.com, Inc. of Seattle, WA and VIZIO of Irvine, CA as respondents. *Id.* The Office of Unfair Import Investigations is not a party in this investigation. *Id.*

On August 30, 2023, Complainant DivX filed an unopposed motion for termination as to Respondent VIZIO based on settlement and withdrawal of the complaint as to VIZIO. DivX provided both confidential and public versions of the settlement agreement as required by the Commission Rules.

On September 11, 2023, the ALJ issued the subject ID (Order No. 33) granting complainant DivX's unopposed motion for termination of the investigation as to respondent VIZIO. The ID found the motion complied with the Commission's Rules and termination of respondent VIZIO "by settlement will not adversely affect the public interest." ID at 3. No petitions for review were filed.

The Commission has determined not to review the subject ID. Respondent VIZIO is hereby terminated from the investigation.

The Commission vote for this determination took place on October 11, 2023.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, and in Part 210 of the Commission's Rules of Practice and Procedure, 19 CFR Part 210.
