SUPPLEMENTARY INFORMATION: On December 6, 2023, the Commission instituted this investigation based on a complaint filed by Samsung Display Co., Ltd. of Gyeonggi-do, Republic of Korea. 88 FR 84829-30 (Dec. 6, 2023). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337 based upon the importation into the United States, the sale for importation, or sale within the United States after importation of certain organic light-emitting diode (OLED) display modules, OLED display panels, and components of OLED display modules or panels by reason of misappropriation of trade secrets, the threat or effect of which is to destroy or substantially injure a domestic industry or to prevent the establishment of an industry in the United States. *Id.* at 84829. The Commission's notice of investigation named as respondents BOE Technology Group Co., Ltd. of Beijing, China; Mianyang BOE Optoelectronics Technology Co., Ltd. of Mianyang, Sichuan, China; Ordos Yuansheng Optoelectronics Co., Ltd. of Ordos, Inner Mongolia

Autonomous Region, China; Chengdu BOE Optoelectronics Technology Co., Ltd. of Chengdu, Sichuan, China; Chongqing BOE Optoelectronics Technology Co., Ltd. of Shuitu Hi-tech Industrial Zone, Chongqing, China; Wuhan BOE Optoelectronics Technology Co., Ltd. of Wuhan, Hubei, China; BMOT f/k/a Kunming BOE Display Technology of Da Ban Qiao subdistrict office of Yunnan Dianzhong New Area, China; and BOE Technology America Inc. of Santa Clara, California. *Id.* at 84830. The Office of Unfair Import Investigations was also named as a party in this investigation. *Id.*

On December 20, 2023, the ALJ issued the subject ID. The ID stated that the target date for this investigation will be May 29, 2025, with the final ID on violation due no later than January 29, 2025. No petitions for review of the ID were filed.

The Commission has determined not to review the subject ID.

The Commission vote for this determination took place on January 19, 2024.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
