## NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION GRANTING COMPLAINANTS' MOTION FOR PARTIAL TERMINATION OF THIS INVESTIGATION AS TO CERTAIN CLAIMS

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 20) terminating the investigation as to claims 3, 12, 17, and 33 of United States Patent No. 7,532,808 ("the '808 patent").

**SUPPLEMENTARY INFORMATION**: On December 6, 2023, the Commission instituted this investigation based on a complaint filed by Nokia Technologies Oy and Nokia Corporation, both of Espo, Finland (collectively, "Complainants"). 88 FR 84832-33 (Dec. 6, 2023). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337 based upon the importation into the United States, the sale for importation, or sale within the United States after importation of certain video capable electronic devices, including computers, streaming devices, televisions, cameras, and components and modules thereof by reason of the infringement of one or more of claims 1-3, 6, 7, 9-12, 15-17, 20-25, 28-30, 32-34, 36, 39-41, 43, 44, 47-49, 51-54, 58-60, and 62-65 of the '808 patent and claims 1-22 of U.S. Patent No. 8,204,134 ("the '134 patent"). *Id.* at 84832. The Commission's notice of investigation named as respondents HP, Inc. of Palo Alto, California; and Amazon.com, Inc. and Amazon.com Services

LLC, both of Seattle, Washington (collectively, "Respondents"). The Office of Unfair Import Investigations ("OUII") was also named as a party in this investigation. *Id*.

On January 31, 2024, Complainants moved for partial termination of the investigation by withdrawal of claims 3, 12, 17, and 33 of the '808 patent. EDIS Doc. ID 812945. The motion states that Respondents and OUII do not oppose. *Id*.

On February 2, 2024, the ALJ granted the unopposed motion. The ID found that the motion complies with the Commission Rules. ID at 1-2. The ID further found that there are no extraordinary circumstances that warrant denying the motion. *Id.* at 2. No petitions for review of the ID were filed.

The Commission has determined not to review the subject ID. The following claims are terminated from the investigation: claims 3, 12, 17, and 33 of the '808 patent.

The Commission vote for this determination took place on February 15, 2024.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
