**NOTICE OF A COMMISSION DETERMINATION TO EXTEND THE DATE BY
WHICH TO DETERMINE WHETHER TO REVIEW A REMAND INITIAL
DETERMINATION FINDING THAT COMPLAINANT HAS SATISFIED THE
ECONOMIC PRONG OF THE DOMESTIC INDUSTRY REQUIREMENT**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined to extend the date by which to determine whether to review a remand initial determination (“ID”) of the presiding administrative law judge (“ALJ”), finding that PAX Labs, Inc. (“Complainant”) has satisfied the economic prong of the domestic industry requirement, to September 17, 2025.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on March 6, 2024, based on a complaint filed by Complainant. 89 FR 16025-26 (Mar. 6, 2024). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337 (“section 337”), in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain oil vaporizing devices, components thereof, and products containing the same by reason of infringement of certain claims of U.S. Patent Nos. 11,369,756; 11,766,527; 11,369,757; and 11,759,580 (“the ’580 patent”). *Id.* The complaint further alleges that a domestic industry exists. *Id.* The Commission’s notice of investigation named as respondents STIIZY IP LLC f/k/a STIIZY,

LLC; STIIIZY, Inc. d/b/a Shryne Group Inc.; ALD Group Limited; and ALD Hong Kong Holdings (collectively, “Respondents”) *Id.* The Office of Unfair Import Investigations is not participating in the investigation. *Id.*

On March 6, 2025, the ALJ issued the final ID finding no violation of section 337. Complainant and Respondents filed petitions for review of the final ID on March 18, 2025, and filed replies to each others’ petitions on March 26, 2025.

On May 16, 2025, the Commission remanded the investigation, directing the ALJ to reconsider whether Complainant satisfied the economic prong of the domestic industry requirement. The Commission also determined to review the final ID’s findings that: (1) certain accused products do not infringe the ’580 patent; and (2) certain redesigned products infringe the ’580 patent.

On July 18, 2025, the ALJ issued the subject remand ID, finding that Complainant has satisfied the economic prong of the domestic industry requirement under section 337(a)(3)(A) and (B). On July 30, 2025, Respondents filed a petition for review of the remand ID. On August 6, 2025, Complainant submitted a response to Respondents’ petition for review.

The Commission has determined to extend the date by which it must determine whether to review the remand ID to September 17, 2025.

The Commission vote for this determination took place on September 3, 2025.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission’s Rules of Practice and Procedure (19 CFR Part 210).
