**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL  
DETERMINATION TERMINATING RESPONDENTS HKC CORPORATION LTD.  
AND HKC OVERSEAS LTD. BASED ON SETTLEMENT**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 24) of the presiding administrative law judge (“ALJ”) granting an unopposed motion to terminate this investigation as to respondents HKC Corporation Ltd. of Shenzhen City, Guangdong Province, China and HKC Overseas Ltd. of Hong Kong (collectively, “HKC”) based on settlement.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on March 7, 2025, based on a complaint filed by Corning Incorporated of Corning, New York (“Corning”). 90 FR 11549-50 (Mar. 7, 2025). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain glass substrates for liquid crystal displays, products containing the same, and methods for manufacturing the same by reason of the infringement of

U.S. Patent Nos. 7,851,394; 8,642,491; and 8,640,498. *Id.* at 11549. The complaint further alleges that a domestic industry exists. *Id.*

The notice of investigation names, in addition to HKC, respondents: (1) Caihong Display Devices Co., Ltd., d/b/a Irico Display Devices Co., Ltd. of Xianyang City, Shaanxi Province, China; (2) Hisense USA Corporation of Suwanee, Georgia; (3) LG Electronics U.S.A., Inc. of Englewood Cliffs, New Jersey; (4) TCL China Star Optoelectronics Technology Co., Ltd. of Shenzhen City, Guangdong Province, China; (5) TTE Technology, Inc., d/b/a TCL North America of Irvine, California; (6) VIZIO, Inc. of Irvine, California; and (7) Xianyang CaiHong Optoelectronics Technology Co., Ltd. of Xianyang City, Shaanxi Province, China. *Id.* The Office of Unfair Import Investigations is not named as a party to this investigation. *Id.*

On May 20, 2025, Corning filed an unopposed motion to, *inter alia*, terminate the investigation as to HKC based on a settlement agreement. No response to the motion was filed.

On July 15, 2025, the ALJ issued the subject ID (Order No. 24) granting the motion to terminate the investigation as to HKC. The ID finds that the motion complies with the requirements of Commission Rule 210.21(b)(1) (19 CFR 210.21(b)(1)), and that the proposed settlement does not adversely affect the public interest in accordance with Commission Rule 210.50(b)(2) (19 CFR 210.50(b)(2)). No petitions for review of the subject ID were filed.

The Commission has determined not to review the subject ID. The investigation is terminated as to HKC.

The Commission vote for this determination took place on August 6, 2025.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
