Notice of a Commission Determination Not to Review an Initial Determination Granting Complainant's Unopposed Motion to Terminate the Investigation Based on Withdrawal of the Complaint; Termination of the Investigation

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission ("Commission") has determined not to review an initial determination ("ID") (Order No. 8) of the presiding administrative law judge ("ALJ"), granting complainant Wahoo Fitness L.L.C.'s ("Wahoo's") motion to terminate the investigation based on withdrawal of the complaint. The investigation is terminated.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on January 7, 2026, based on a complaint filed by Wahoo of Atlanta, Georgia. 91 FR 540-41 (Jan. 7, 2026). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of

1930, as amended, 19 U.S.C. 1337, in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain bicycle trainers and components thereof by reason of infringement of one or more of claims 1, 4, 6, 7, 11, 12, and 14-16 of U.S. Patent No. 10,933,290; claim 16 of U.S. Patent No. 11,090,542; claims 1-4, 8-11, and 13-18 of U.S. Patent No. 11,559,732; and claims 1-3 and 5-9 of U.S. Patent No. 12,330,036. *Id.* The complaint further alleges that a domestic industry exists. *Id.* at 540. The Commission's notice of investigation named as respondent JetBlack Cycling Pty Ltd. ("JetBlack") of South Windsor, Australia. *Id.* at 541. The Office of Unfair Import Investigations is not a party to this investigation. *Id.*

On February 6, 2026, Wahoo filed an unopposed motion to terminate the investigation based on withdrawal of the complaint. The motion explains that on February 3, 2026, the United States District Court for the Northern District of Georgia issued a preliminary injunction ordering Wahoo to withdraw the complaint in this investigation based on a forum selection clause in a prior settlement agreement between the parties. Wahoo disagreed with the decision but filed the motion in compliance with the order. The motion further states that JetBlack did not oppose the motion.

On February 9, 2026, the ALJ issued the subject ID (Order No. 8) granting the motion to terminate. The ID notes that the motion complies with Commission Rule 210.21(a)(1) (19 CFR 210.21(a)(1)), and that there are no extraordinary circumstances that would prevent the requested relief. Order No. 8 at 1. No petitions for review of the ID were filed.

The Commission has determined not to review the subject ID. This investigation is terminated.

The Commission vote for this determination took place on March 6, 2026.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
