AS TO ONE RESPONDENT; ISSUANCE OF CONSENT ORDER**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 10) of the presiding administrative law judge ("ALJ") terminating the above-captioned investigation as to Chi Mei Lighting Technology Corp. ("Chi Mei") based on a consent order stipulation and proposed consent order.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on April 6, 2009, based on a complaint filed on March 2, 2009, by Gertrude Neumark Rothschild of Hartsdale, New York. 74 *Fed. Reg.* 15520-21 (April 6, 2009). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain light emitting diodes chips, laser diode chips, and products containing same by reason of infringement of certain claims of U.S. Patent No. 5,252,499. The complaint further alleges that an industry in the United States exists as required by subsection (a)(2) of section 337. The complaint names numerous respondents, including Chi Mei of Tainan County, Taiwan.

On April 20, 2009, respondent Chi Mei moved to terminate the investigation as to Chi Mei on the basis of a consent order stipulation and proposed consent order. Complainant opposed the motion, and the Commission investigative attorney supported the motion.

The ALJ issued the subject ID on June 23, 2009, granting the motion for termination. No party petitioned for review of the ID. The Commission has determined not to review the subject ID and to issue a consent order.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, and in sections 210.21 and 210.42(h) of the Commission's Rules of Practice and Procedure, 19 C.F.R. §§ 210.21, 210.42(h).
