## NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION TERMINATING THE INVESTIGATION AS TO RESPONDENT SHANDONG YONGTAI

**SUMMARY**: Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 33) of the presiding administrative law judge ("ALJ") terminating the investigation as to respondent Shandong Yongtai Chemical Group Co., Ltd. based on a settlement agreement.

**SUPPLEMENTARY INFORMATION**: The Commission instituted this investigation under section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, on September 20, 2013, based on a complaint filed by Toyo Tire & Rubber Co., Ltd. of Japan; Toyo Tire Holdings of Americas Inc. of Cypress, California; Toyo Tire U.S.A. Corp. of Cypress, California; Nitto Tire U.S.A. Inc. of Cypress, California; and Toyo Tire North America Manufacturing Inc. of White, Georgia (collectively, "Toyo"). The complaint, as supplemented, alleges violation of section 337 by reason of infringement of certain claims of U.S. Design Patent Nos. D487,424; D610,975; D610,976; D610,977; D615,031; D626,913; D458,214; and D653,200 by numerous respondents. 78 *Fed. Reg.* 57882-83 (Sept. 20, 2013). Subsequently, the complaint and notice of investigation were amended to add Shandong Hengyu Science & Technology Co., Ltd. as respondent, and several other respondents were terminated from the investigation.

On January 28, 2014, complainants Toyo moved to terminate the investigation as to respondent Shandong Yongtai based on a settlement agreement. On February 7, 2014, the Commission investigative attorney filed a response in support of the motion. Shandong Yongtai and respondents Hong Kong Tri-Ace Tire Co., Ltd. and Doublestar Dong Feng Tyre Co., Ltd. did not oppose the motion. Respondent Svizz-One Corporation, Ltd. did not file a response.

On February 10, 2014, the ALJ issued an ID (Order No. 33) granting the motion. The ALJ found that termination of the investigation as to respondent Shandong Yongtai based on settlement does not impose any undue burden on the public health and welfare, competitive conditions in the United States economy, production of like or directly competitive articles in the United States, or United States consumers. No party petitioned for review of ALJ Order No. 33, and the Commission has determined not to review it.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 C.F.R. Part 210).
