SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 35) terminating certain respondents.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on September 26, 2013, based on a complaint filed on behalf of A&J Manufacturing, LLC of St. Simons, Georgia and A&J Manufacturing, Inc. of Green Cove Springs, Florida. 78 Fed. Reg. 59373 (Sept. 26, 2013). The complaint alleged violations of Section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the sale for importation, importation, or sale within the United States after importation of certain multiple mode outdoor grills and parts thereof by reason of infringement of certain claims of U.S. Patent No. 8,381,712, U.S. Patent No. D660,646, and U.S. Patent No. D662,773 patent. The Commission's notice of investigation, as amended,

named several respondents, including Premier Specialty Brands, LLC of Duluth, Georgia ("Premier") and Wuxi Joyray International Corporation of Wuxi, China ("Wuxi").

On April 3, 2014, Complainants and Respondents Wuxi and Premier (collectively "the moving parties") filed a joint motion for partial termination of the investigation as to Premier and Wuxi based on a Consent Order Stipulation and Consent Order. On April 11, 2014 the Office of Unfair Import Investigations (OUII) filed a response in support of the motion. Also on April 11, 2014, the remaining non-moving respondents filed a response partially opposing the motion.

On April 22, 2014, the ALJ granted the motion for termination based on a Consent Order and Consent Order Stipulation as to Premier and Wuxi. Order No. 35. The ALJ found that the Consent Order and Consent Order Stipulation complied with the Commission's rules. The ALJ found that there was no evidence that terminating the investigation as to Premier and Wuxi would be contrary to the public interest. No petitions for review were filed.

The Commission has determined not to review the subject ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 C.F.R. Part 210).
