## NOTICE OF COMMISSION DETERMINATION TO EXTEND THE TIME FOR DETERMINING WHETHER TO REVIEW AN INITIAL DETERMINATION (ORDER NO. 95)

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined to extend the time for determining whether to review an initial determination ("ID") (Order No. 95) in the above-captioned investigation. The ID at issue granted respondents' cross motions for summary determination on lack of domestic industry and terminating the investigation in its entirety. The Commission has extended the time for determining whether to review the ID by one day, until September 3, 2014.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on October 25, 2013, based on a complaint filed by Optical Devices, LLC, of Peterborough, New Hampshire ("Optical"), as supplemented. 78 *Fed. Reg.* 64009-10 (Oct. 25, 2013). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337 or "section 337"), in the importation into the United States, the sale for importation, and

the sale within the United States after importation of certain optical disc drives, components thereof, and products containing the same by reason of infringement of certain claims of various U.S. patents. The complaint further alleges the existence of a domestic industry. The Commission's notice of investigation named as respondents Lenovo Group Ltd. of Quarry Bay, Hong Kong; Lenovo (United States) Inc., of Morrisville, North Carolina; LG Electronics, Inc. of Seoul, Republic of Korea; LG Electronics U.S.A., Inc. of Englewood Cliffs, New Jersey; Nintendo Co., Ltd. of Kyoto, Japan; Nintendo of America, Inc. of Redmond, Washington; Panasonic Corp. of Osaka, Japan; Panasonic Corporation of North America of Secaucus, New Jersey; Samsung Electronics Co., Ltd. of Seoul, Republic of Korea; Samsung Electronics America, Inc. of Ridgefield Park, New Jersey; Toshiba Corporation of Tokyo, Japan; Toshiba America Information Systems, Inc. of Irvine, California; MediaTek, Inc. of Hsinchu City, Taiwan; and MediaTek USA Inc. of San Jose, California (collectively "Respondents"). The Office of Unfair Import Investigations was not named as a party to the investigation.

On July 17, 2014, the administrative law judge ("ALJ") issued Order No. 95, granting the Respondents' cross motions for summary determination on lack of domestic industry and terminating the investigation in its entirety.

The Commission has determined to extend the date for determining whether to review the ID at issue by one day, until September 3, 2014.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 C.F.R. Part 210).
