NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION TERMINATING THE INVESTIGATION AS TO RESPONDENT WIKIPAD, INC., BASED ON A CONSENT ORDER STIPULATION, CONSENT ORDER, AND SETTLEMENT AGREEMENT; ISSUANCE OF CONSENT ORDER

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 6) of the presiding administrative law judge ("ALJ") terminating the above-captioned investigation as to respondent Wikipad, Inc., of Westlake Village, California ("Wikipad"), based on a consent order stipulation, proposed consent order, and settlement agreement. The Commission has issued the consent order.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on December 30, 2014, based on a complaint filed by Samsung Austin Semiconductor, LLC, of Austin, Texas, and Samsung Electronics Co., Ltd., of the Republic of Korea (collectively, "Samsung"). 79 *Fed. Reg.* 78477-78 (Dec. 30, 2014). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), in the importation into the United States, the sale for importation, or the sale within the United States after importation of

certain graphics processing chips, systems on a chip, and products containing the same by reason of infringement of U.S. Patent No. 6,147,385 ("the '385 patent"); U.S. Patent No. 6,173,349 ("the '349 patent"); U.S. Patent No. 7,056,776 ("the '776 patent"); and U.S. Patent No. 7,804,734 ("the '734 patent"). The notice of investigation named numerous respondents, including Wikipad. Samsung alleged that Wikipad products infringed the '385, '349, and '734 patents but not the '776 patent.

On March 11, 2015, Samsung and Wikipad jointly moved to terminate the investigation with respect to Wikipad based on a consent order stipulation, proposed consent order, and settlement agreement. Samsung and Wikipad amended the motion on March 19 and again on March 20, 2015. On March 23, 2015, the other respondents in the investigation filed a statement that they do not oppose the amended motion. Also on March 23, the Commission investigative attorney filed a response supporting the amended motion.

On April 1, 2015, the ALJ issued an ID granting the motion to terminate. The ALJ found that there are no other agreements between Samsung and Wikipad concerning the subject matter of this investigation. The ALJ further found that the consent order stipulation and proposed consent order satisfied Commission Rule 210.21(c). Additionally, the ALJ found, pursuant to Commission Rule 210.50(b)(2), that there was no evidence that terminating the investigation as to Wikipad based on the consent order stipulation, proposed consent order, and settlement agreement would be contrary to the public interest.

The Commission has determined not to review the ID and has issued the consent order.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 C.F.R. Part 210).
