However, there are tariff numbers in chapters 98 and 99 of the HTS which refer to special classification provisions, temporary suspension or increase in duties, or items subject to quotas, for which import classification and statistics are reported under the parent item in HTS Chapters 1 through 97 (for a few provisions import statistics are also reported for the appropriate chapter 98 or 99 item number). Although there are 99 chapters in the HTS, Chapter 77 is blank (reserved for future use), and Chapter 98 (Special Classification provisions) and Chapter 99 (Temporary Legislation; Temporary Modifications; Additional Import Restrictions) are omitted from this count.
