## A BILL

To extend the temporary suspension of duty on DMDS.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DMDS.**

4       (a) IN GENERAL.—Heading 9902.33.92 of the Har-  
5 monized Tariff Schedule of the United States (relating to  
6 2,2-Dithiobis(8-fluoro-5-methoxy)-1,2,4-triazolo[1,5-*c*] py-  
7 rimidine) is amended by striking “12/31/2006” and insert-  
8 ing “12/31/2008”.

9       (b) EFFECTIVE DATE.—The amendment made by  
10 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
