Bill No. and sponsor: S. 2478 (Mr. Mike DeWine of Ohio and Mr. George V. Voinovich of Ohio).

Proponent name, location: Flexsys America L.P., Akron, OH.

Nature of bill: Temporary duty suspension through December 31, 2009.

Tetraethylthiuram disulfide (CAS No. 97-77-8) (provide for in subheading 2930.30.60).

Product information, including uses/applications and source(s) of imports:

This synthetic organic chemical, known by its initials, TETD, is used in rubber compounding to provide good heat aging and compression set resistance for rubber products produced by sulfurless and EV vulcanization systems. This chemical is imported from Germany.

3 **SECTION 1. TETRAETHYLTHIURAM DISULFIDE.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:
