
ε-Caprolactone polymer with poly(1,4-butylene glycol) (CAS No. 9051-88-1) (provided for in subheading 3907.99.01).

3 **SECTION 1. 2-OXEPANONE, POLYMER WITH ALPHA-HYDRO-**  
4 **OMEGA-HYROXYPOLY (OXY-1,4-BUTANEDIYL).**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of  
6 the Harmonized Tariff Schedule of the United States is  
7 amended by inserting in numerical sequence the following  
8 new heading:
