4-Chloro-3,5-dinitro- α,α,α -trifluorotoluene (CAS No. 393-75-9) (provided for in subheading 2904.90.15).

Product information, including uses/applications and source(s) of imports:

The subject product is a synthetic organic chemical that is used as an intermediate in the manufacture of flumetralin technical, which is used to control suckers in tobacco crops.⁴ The subject product is imported from Italy.
