**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 110th Congress¹**

Bill No. and sponsor: H.R. 5118 (Mr. Kenny Hulshof of Missouri).

Proponent name,³ location: Bayer CropScience, Research Triangle Park, NC.

Other bills on product (110th Congress only): None.

Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Aluminum tris (O-ethylphosphonate) (Fosetyl-Al) (CAS No. 39148-24-8) (provided for in subheading 2920.90.50).

Product information, including uses/applications and source(s) of imports:

The subject product is a synthetic organic chemical that is used as a fungicide to control *Alternaria*, *Oomycetes*, and *Penicillium* on avocado, cacao, citrus, fruits, hops, ornamentals, pineapple, rubber, strawberries, tobacco, vegetables, and vines. The product also suppresses certain bacterial pathogens, *Erwinia* fire blight and *Pseudomonas* blister spot on pome fruit, and *Xanthomonas* on ornamentals. The product is imported from France.

1 *Be it enacted by the Senate and House of Representa-*

3 **SECTION 1. ALUMINUM TRIS (O-ETHYLPHOSPHONATE).**

4 (a) IN GENERAL.—Heading 9902.01.73 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 Aluminum tris (O-ethylphosphonate)) is amended by strik-
7 ing the date in the effective period column and inserting
8 “12/31/2011”.

9 (b) EFFECTIVE DATE.—The amendment made by
10 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
