Bill No. and sponsor: H.R. 5339 (Mrs. Judy Biggert of Illinois).

Proponent name,³ location: Nufarm Americas, Inc., Burr Ridge, IL.

Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

3,5-Dibromo-4-hydroxybenzotrile octanoate (Bromoxynil octanoate) (CAS No. 1689-99-2) (provided for in subheading 2926.90.25).

Product information, including uses/applications and source(s) of imports:

The subject product is a synthetic organic chemical that is used as a herbicide to control broadleaf weeds in certain vegetables, cereals, forage grasses, and turf. The product is imported from France and the United Kingdom.

Technical comments:⁴

The Commission staff suggests that the article description on page 1 of this report be used in HTS heading 9902.22.97 because it contains the correct CAS number and it includes the common name in parentheses. The Commission staff notes that HTS heading 9902.10.56 also provides a temporary duty suspension for bromoxynil octanoate that expires on December 31, 2009. If this bill is enacted, HTS heading 9902.10.56 should be deleted from the HTS.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. BROMOXYNIL OCTONOATE.**

4 (a) IN GENERAL.—Heading 9902.22.97 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 Bromoxynil Octonoate) is amended by striking the date
7 in the effective period column and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
