Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

(+)-(R)-2-(2,4-Dichlorophenoxy) propanoic acid (Dichlorprop-p) (CAS No. 15165-67-0) (provided for in subheading 2918.99.20); (+)-(R)-2-(2,4-dichlorophenoxy) propanoic acid, 2-ethylhexyl ester (Dichlorprop-2-ethylhexyl) (CAS No. 79270-78-3) (provided for in subheading 2918.99.20); and (+)-(R)-2-(2,4-dichlorophenoxy) propanoic acid, dimethylamine salt (Dichlorprop-P-dimethylammonium) (CAS No. 104786-87-0) (provided for in subheading 2921.11.00).

Product information, including uses/applications and source(s) of imports:

The subject synthetic organic chemicals are herbicides that are used to rid lawns of woody weed species. They are often applied in combination with other herbicides as a direct spray on turf and lawns. The products are imported from the Netherlands and the United Kingdom.

The Commission staff recommends that the article description on page 1 of this report be used in HTS heading 9902.23.25 in order to insert the common chemical names in parentheses and to provide the correct HTS subheading reference.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

To extend the temporary suspension of duty on dichlorprop-p acid, dichlorprop-p dimethylamine salt, and dichlorprop-p 2-ethylhexyl ester.

3 **SECTION 1. DICHLORPROP-P ACID, DICHLORPROP-P DI-**
4 **METHYLAMINE SALT, AND DICHLORPROP-P 2-**
5 **ETHYLHEXYL ESTER.**

6 (a) IN GENERAL.—Heading 9902.23.25 of the Har-
7 monized Tariff Schedule of the United States (relating to
8 dichlorprop-p acid, dichlorprop-p dimethylamine salt, and
9 dichlorprop-p 2-ethylhexyl ester) is amended by striking

1 the date in the effective period column and inserting “12/
2 31/2011”.

3 (b) **EFFECTIVE DATE.**—The amendment made by
4 subsection (a) applies to goods entered, or withdrawn from
5 warehouse for consumption, on or after the 15th day after
6 the date of the enactment of this Act.
