Proponent name,³ location: Chemtura Corporation, Middlebury, CT.

Nature of bill: Extension of temporary duty suspension through December 31, 2011.⁴

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

2,2,6,6-Tetramethyl-4-piperidinone (CAS No. 826-36-8) (provided for in subheading 2933.39.61).

Product information, including uses/applications and source(s) of imports:

The subject product, imported from Germany and commonly known as triacetoneamine, is used as a raw material in the manufacture of a range of chemicals that are used to control the development of unwanted polymers during the curing of rubbers and plastics.

4 (a) IN GENERAL.—Heading 9902.25.07 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 2,2,6,6-Tetramethyl-4-piperidinone) is amended by strik-
7 ing “12/31/2009” and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
