**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 111th Congress¹**

Bill No. and sponsor: S. 2382 (Mr. George V. Voinovich of Ohio and Mr. Sherrod Brown of Ohio).

Proponent name,³ location: Luxottica Group, S.p.A., Mason, OH.

Other bills on product (111th Congress only): None.

Nature of bill: Temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Parts of frames and mountings for spectacles, goggles or the like (provided for in subheading 9003.90.00).

Check one: Same as that in bill as introduced.

Product information, including uses/applications and source(s) of imports:

Parts of frames and mountings for spectacles, goggles, and the like include spectacle side pieces and side piece cores, hinges or joints, eye-rims, bridges, nose-pieces, spring devices for pince-nez, and other parts. The side pieces, known as temples, usually curve around the wearer's ears. Hinges and joints connect the temples and eye rims holding the lenses, and attach the nose-pieces, the part of a pair of eyeglasses that fits across the nose. Spring devices are used to clip pince-nez, which are eyeglasses that are held in place only by means of a clip over the bridge of the nose, to the wearer's nose.

Austria, China, Italy, and Japan are the primary import sources.
