## II. Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Viscose rayon staple fibers having a decitex of less than 5.0 and a multi-limbed cross-section, the limbs having a length-to-width aspect ratio of at least 2:1 (provided for in subheading 5504.10.00)

(If enacted, the tariff relief provided for in this bill would be available to any entity that imports the product that is covered by the bill.)

## III. Other product information, including uses/applications and source(s) of imports

Viscose rayon is an artificial manmade fiber produced from cellulosic materials such as wood pulp, which is processed into viscose liquid and extruded through perforated metal disks (spinnerets) into an acid bath to produce long fiber strands. The viscose rayon strands are then cut to produce staple fibers. Rayon fibers included in subheading 9902.55.04 are used in the production of industrial and household products including tampons, sanitary wipes, baby wipes, rayon mops, and other household cleaning products. Imports of these rayon staple fibers are primarily from Germany.

## V. Technical comments

The title to H.R. 4583 indicates that it is an extension of a temporary duty suspension, but it actually extends the current temporary duty reduction set at 1.8 percent ad valorem (from the column 1 rate of 4.3 percent) from December 31, 2012 to December 31, 2015. H.R. 4947 and S. 2838 also cover rayon fibers under heading 9902.55.04; these bills each seek a duty reduction to 1.3 percent. In addition to the bills noted above, at least some of the rayon fibers eligible for heading

9902.55.04 may also qualify under heading 9902.23.33, the subject of identical bills H.R. 4603 and H.R. 4422. The article description of heading 9902.55.04 contains a decitex standard that overlaps that of heading 9902.23.33. However, the former specifies that only multi-limbed fibers are included, while heading 9902.23.33 contains a wider range of potential fiber length. This potentially overlapping scope makes it impossible to estimate with any certainty the volume of imports under each bill.

## A BILL

To extend the suspension of duty on staple fibers of viscose rayon, not carded, combed or otherwise processed for spinning.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. STAPLE FIBERS OF VISCOSE RAYON, NOT**  
4 **CARDED, COMBED OR OTHERWISE PROC-**  
5 **ESSED FOR SPINNING.**

6 (a) IN GENERAL.—Heading 9902.55.04 of the Har-  
7 monized Tariff Schedule of the United States (relating to  
8 staple fibers of viscose rayon, not carded, combed or other-  
9 wise processed for spinning) is amended by striking the

1 date in the effective period column and inserting “12/31/  
2 2015”.

3 (b) **EFFECTIVE DATE.**—The amendment made by  
4 this section applies to goods entered, or withdrawn from  
5 warehouse for consumption, on or after the 15th day after  
6 the date of the enactment of this Act.
