**III. Other product information, including uses/applications and source(s) of imports**

The subject products, porcelain lamp-holder housings containing sockets, are one type of lamp-holder (bulb holder). Lamp-holders provide an electrical housing for bulb insertion in various types of lighting fixtures. Lamp-holders vary in style, electrical rating, and constituent materials and may be used for incandescent, fluorescent, or other lighting devices. There are numerous configurations, including snap-in, plug-in, and screw-in, based on end-use requirements. Porcelain lamp-holder housings containing sockets are typically used with high heat fixtures such as recessed lighting. The principal U.S. import sources of this product are China, Mexico, and Germany. Total U.S. imports of all lamp-holders classified in subheading 8536.61.00, a broader category than just the subject product, totaled \$88 million in 2011. Opposition to this bill is noted below in the Contacts table.

## A BILL

To extend the temporary suspension of duty on certain porcelain lamp-holder housings.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. CERTAIN PORCELAIN LAMP-HOLDER**  
4       **HOUSINGS.**

5       (a) IN GENERAL.—Heading 9902.23.30 of the Har-  
6       monized Tariff Schedule of the United States (relating to  
7       certain porcelain lamp-holder housings) is amended by  
8       striking “12/31/2012” and inserting “12/31/2015”.

9       (b) EFFECTIVE DATE.—The amendments made by  
10      subsection (a) apply with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of enactment of this Act.
