GENERAL INFORMATION

Background.-- On September 7, 2001, the Department of Commerce issued antidumping duty orders on imports of steel concrete reinforcing bar (“rebar”) from Belarus, China, Indonesia, Latvia, Moldova, Poland, and Ukraine (66 F.R. 46777).

On August 9, 2007, The Department of Commerce issued continuation of antidumping duty orders on imports of rebar from Belarus, China, Indonesia, Latvia, Moldova, Poland, and Ukraine (72 F.R. 44830).

On July 2, 2012, the Commission instituted reviews pursuant to section 751(c) of the Tariff Act of 1930 (19 U.S.C. § 1675(c)) (the Act) to determine whether revocation of the orders would be likely to lead to continuation or recurrence of material injury to the domestic industry within a reasonably foreseeable time (77 F.R. 39254). If Commerce and the Commission make affirmative determinations, the orders will remain in place. If either agency makes negative determinations, Commerce will revoke the order.

Due date of questionnaire(s).--Please submit the completed questionnaire(s) to the United States International Trade Commission so as to be received by **no later than FEBRUARY 20, 2013**. Because Commission staff might contact you with questions during the course of the proceeding, save the final version of the document(s) and retain all files and worksheets associated with the completed questionnaire(s). Please also retain a copy of any paper original document that you submit.

Service of questionnaire response(s).--In the event that your firm is a party to this proceeding, you are required to serve a copy of the questionnaire(s), once completed, on parties to the proceeding that are subject to administrative protective order (see 19 CFR § 207.7). A list of such parties is maintained by the Commission’s Secretary and may be obtained by calling 202-205-1803. A certificate of service must accompany the copy of the completed questionnaire(s) you submit (see 19 CFR § 207.7).

Confidentiality.--The commercial and financial data furnished in response to the enclosed questionnaire(s) that reveal the individual operations of your firm will be treated as confidential by the Commission to the extent that such data are not otherwise available to the public and will not be disclosed except as may be required by law (see 19 U.S.C. § 1677f). Such confidential information will not be published in a manner that will reveal the individual operations of your firm; however, nonnumerical characterizations of numerical business proprietary information (such as discussion of trends) will be treated as confidential business information only at the request of the submitter for good cause shown.

GENERAL INFORMATION--Continued

Verification.--The information submitted in the enclosed questionnaire(s) is subject to audit and verification by the Commission. To facilitate possible verification of data, please keep all of your files, worksheets, and supporting documents used in the preparation of the questionnaire response(s).

Release of information.--The information provided by your firm in response to the questionnaire(s), as well as any other business proprietary information submitted by your firm to the Commission in connection with the proceeding, may become subject to, and released under, the administrative protective order provisions of the Tariff Act of 1930 (19 U.S.C. § 1677f) and section 207.7 of the Commission's Rules of Practice and Procedure (19 CFR § 207.7). This means that certain lawyers and other authorized individuals may temporarily be given access to the information for use in connection with this proceeding or other import-injury proceedings conducted by the Commission on the same or similar merchandise; those individuals would be subject to severe penalties if the information were divulged to unauthorized individuals.

INSTRUCTIONS

Answer all questions.--Do not leave any question or section blank unless a questionnaire expressly directs you to skip over certain questions or sections. If the answer to any question is "none," write "none." **If information is not readily available from your records in exactly the form requested, furnish carefully prepared estimates.** Answers to questions and any necessary comments or explanations should be supplied in the space provided or on separate sheets attached to the appropriate page of the questionnaire(s). If your firm is completing more than one questionnaire in connection with this proceeding (i.e., a producer, importer, purchaser, and/or foreign producer questionnaire), you need not respond to duplicated questions in the questionnaires. Questionnaires may be filed either electronically or in paper form.

Consolidate all establishments in Belarus, China, Indonesia, Latvia, Moldova, Poland, and/or Ukraine.--Report the requested data for your establishment(s) located in Belarus, China, Indonesia, Latvia, Moldova, Poland, and/or Ukraine. **Firms operating more than one establishment should combine the data for all establishments in each country into a single report.**

Electronic completion.--Your firm is encouraged to complete the questionnaire electronically in MS Word format. The MS Word versions of all the questionnaires in this proceeding are available online at the ITC web page or may be obtained directly from the Commission's Investigator, Joanna Lo (joanna.lo@usitc.gov, or 202-205-1888).

Electronic submission.--To the degree that it is possible and not overly burdensome, the Commission requests that responding firms submit their questionnaire responses electronically in MS Word format. The submission of questionnaire responses in the MS Word format allows the Commission to compile, assess, and analyze submitted data more promptly. There are three electronic submissions options detailed below. Paper submissions are also accepted.

OPTIONS FOR FILING

This questionnaire is available as a “fillable” form in MS Word format on the Commission’s website at **COPY AND PASTE LINK TO INVESTIGATION FROM ACTIVE INVESTIGATIONS PAGE**. *Please do not attempt to modify the format or permissions of the questionnaire document.* You may complete the questionnaire and submit it, electronically, or you may print it out and submit it in paper form, as described below:

- **Upload via Secure Drop Box.**—Upload the completed questionnaire in MS Word format along with a scanned copy of the signed certification page (page 1) through the Commission’s secure upload facility:

- **Compact disc (CD).**—Copy your questionnaire onto a CD, include a signed certification page (page 1) (either in paper form or scanned PDF copied onto CD), and mail to the address above. *It is strongly recommended that you use an overnight mail service. U.S. mail sent to government offices undergoes additional processing which not only results in substantial delays in delivery but may also damage CDs.*
- **E-mail.**—E-mail your questionnaire to the investigator identified on page 1 of the Instruction Booklet; include a scanned PDF of the signed certification page (page 1). Note: If you are a party to the proceeding, and service of the questionnaire is required, such service should be made in paper form.

DEFINITIONS

Product.-- All steel concrete reinforcing bars sold in straight lengths, as covered by statistical reporting numbers 7214.20.00, 7222.11.0050, 7222.30.0000, 7228.20.1000, 7228.30.8050, 7228.60.6000 of the Harmonized Tariff Schedule of the United States (HTS).¹ *Specifically excluded* are plain rounds (i.e., non deformed or smooth bars) and rebar that has been further processed through bending or coating.

Firm.--An individual proprietorship, partnership, joint venture, association, corporation (including any subsidiary corporation), business trust, cooperative, trustee in bankruptcy, or receiver under decree of any court.

Related firm.--A firm that your firm solely or jointly owned, managed, or otherwise controlled; a firm that solely or jointly owned, managed, or otherwise controlled your firm; and/or a firm that was solely or jointly owned, managed, or otherwise controlled by a firm that also solely or jointly owned, managed, or otherwise controlled your firm.

Establishment.--Each facility of a firm in Belarus, China, Indonesia, Latvia, Moldova, Poland, or Ukraine involved in the production of rebar (as defined above), including auxiliary facilities operated in conjunction with (whether or not physically separate from) such facilities.

United States.--For purposes of this proceeding, the 50 States, Puerto Rico, the U.S. Virgin Islands, and the District of Columbia.

Importer.--Any person or firm engaged, either directly or through a parent company or subsidiary, in importing rebar (as defined above) into the United States from a foreign manufacturer or through its selling agent.

Average production capacity.--The level of production that your establishment(s) could reasonably have expected to attain during the specified periods. Assume normal operating conditions (i.e., using equipment and machinery in place and ready to operate; normal operating levels (hours per week/weeks per year) and time for downtime, maintenance, repair, and cleanup; and a typical or representative product mix).

Production.--All production in your establishment(s) in Belarus, China, Indonesia, Latvia, Moldova, Poland, or Ukraine, including production consumed internally within your firm.

¹ HTS numbers 7214.20.0000, 7228.20.1000, and 7228.60.6000 were valid throughout 2007-12, while HTS 7222.11.0050 became obsolete effective July 2009 and was replaced by HTS 7222.11.0055 and 7222.11.0080 in July 2009 and HTS 7222.11.0056 and 7222.11.0081 in January 2011; HTS 7222.30.0000 became obsolete effective July 2009 and was replaced by HTS 7222.30.0010 and 7222.30.0080 in July 2009 and HTS 7222.30.0001, 7222.30.0011, and 7222.30.0081 in January 2011; and HTS 7228.30.8050 became obsolete effective January 2010 and was replaced by HTS 7228.30.8010 and 7228.30.8060 in January 2010 and HTS 7228.30.8015, 7228.30.8040, and 7228.30.8070 in July 2011.

DEFINITIONS--Continued

Shipments.--Shipments of products produced in your establishment(s) in Belarus, China, Indonesia, Latvia, Moldova, Poland, or Ukraine.

Shipment quantities.—Quantities reported should be net of returns.

Shipment values.—Values reported should be net values (i.e., gross sales values less all discounts, allowances, rebates, prepaid freight, and the value of returned goods) in U.S. dollars, f.o.b. your point of shipment in Belarus, China, Indonesia, Latvia, Moldova, Poland, or Ukraine.

Home market commercial shipments.--Shipments, other than internal consumption and transfers to related firms, within Belarus, China, Indonesia, Latvia, Moldova, Poland, or Ukraine.

Home market internal consumption/transfers to related firms.--Shipments made to related firms in Belarus, China, Indonesia, Latvia, Moldova, Poland, or Ukraine, including product consumed internally by your firm.

Export shipments.--Shipments to destinations outside Belarus, China, Indonesia, Latvia, Moldova, Poland, or Ukraine, including shipments to related firms.

Inventories.--Finished goods inventory, not raw materials or work-in-progress.
